realistic forest policies and programs. USDA Forest Service regional research stations are responsible for conducting these inventories and publishing summary reports for individual States. In addition to published reports, the Forest Service provides data collected in each inventory to those interested in further analysis. This report describes a standard format in which data can be obtained. This standard format, referred to as the Forest Inventory and Analysis Database (FIADB) structure, was developed to provide users with as much data as possible in a consistent manner among States. A number of inventories conducted prior to the implementation of the annual inventory are available in the FIADB. However, various data attributes may be empty or the items may have been collected or computed differently. Annual inventories use a common plot design and common data collection procedures nationwide, resulting in greater consistency among FIA work units than earlier inventories. Data field definitions note inconsistencies caused by different sampling designs and processing methods.
